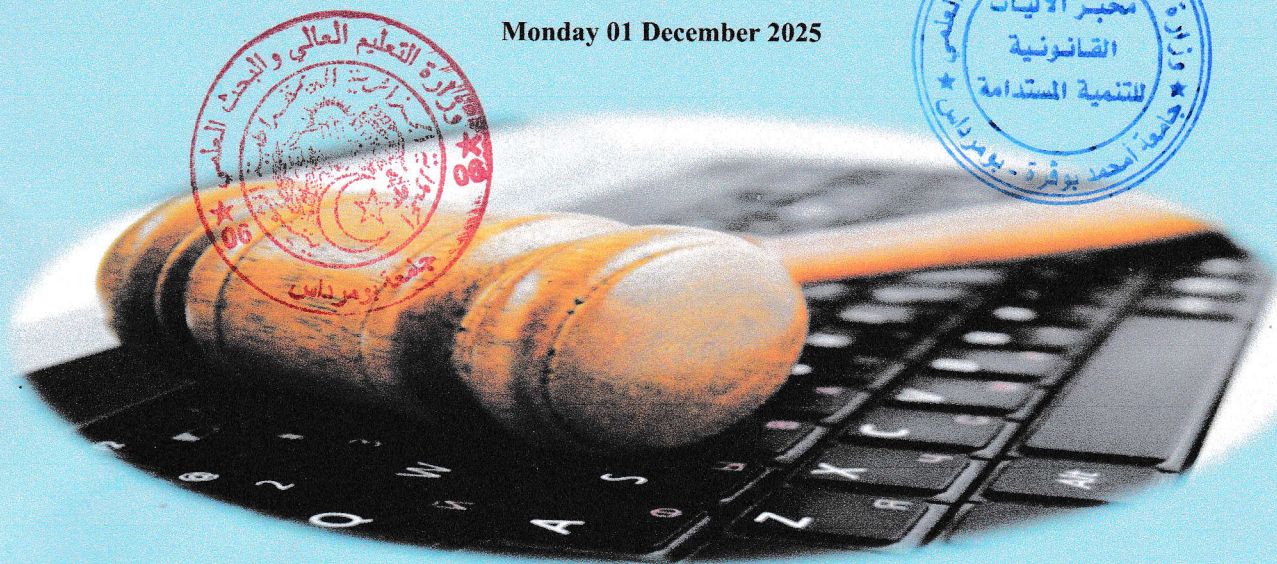

Preamble to the Forum

While digital transformation still raises often exaggerated concerns, it is witnessing amazing technological developments, making it the first assistant on tasks that were impossible to do before now. In support of administrations, its use can significantly improve the quality of public service provided to citizens.

Based on these transformations, the country seeks to implement a digital transformation strategy through which it aspires to serve public performance. A strategy that will create conditions of trust, resourcefulness and governance commensurate with its ambitions of enabling rapid problem solving through machine learning, and providing an opportunity to improve the quality of public service.

On the other hand, these recent developments have exacerbated greatly exaggerated fears (infringement of personal freedoms, manipulation of behaviors, mass surveillance, etc.).

Because digital transformation is a technological transformation, it now calls for a legal transformation that must be implemented, both nationally and internationally.

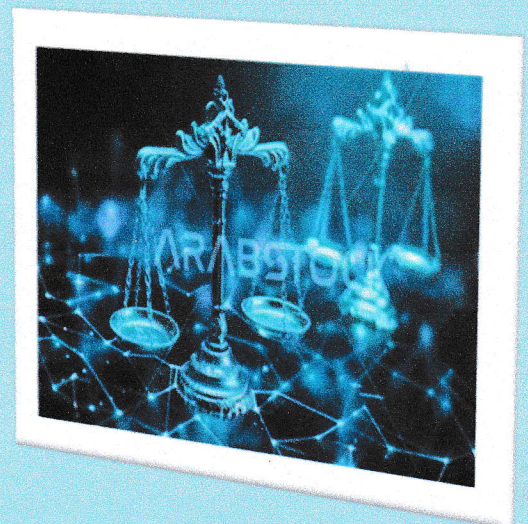
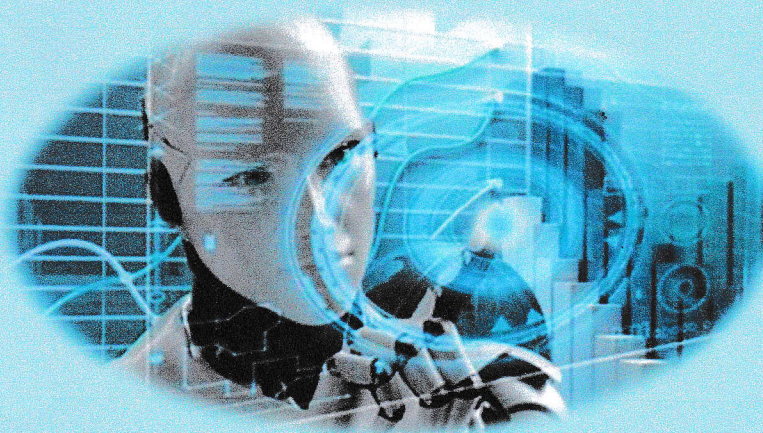
This transformation must focus primarily on the essence of the rule of law and the state, the protection of fundamental rights, security and public safety. In this regard, digital technologies have contradictory effects: they stimulate the exercise of rights, but they also collect unprecedented risks. The current legal system is now insufficient to intervene in solving the various problems arising from the uses of digital transformation, and it has become necessary to achieve legal security by adapting the legal text to digital transformations, and starting to think about reformulating the scope of application of basic protection and the conditions for its effectiveness.

Objectives of the Forum

- Addressing various concepts related to achieving legal security and digital transformation
- Promote development and growth in the field of legal and administrative sciences at the internal level.
- Highlighting new areas of research and innovation in the field of law, enhancing the exchange of views between researchers from different countries of the world, and benefiting from different experiences in the field of digital transformation and its impact on achieving legal security.
- Contribute to directing public policies through the recommendations of the forum, which in turn contribute to influencing decision-making.

The problem of the forum

Considering that the state is the one that regulates social and economic relations, and it also guarantees the basic rights of individuals and public order, being sovereign, and a stakeholder in drafting its legislation, the challenges posed by digital transformation call for a revolution in reconsidering the legal system and adapting it in a homogeneous and ambitious manner aimed at putting digital technologies at the service of basic rights and achieving legal security, and thus the digital revolution goes hand in hand with the revolution observed in the field. Hence, the question that arises lies in what are the tools to achieve legal security in light of conflicting standards and the use of new intangible technologies that go beyond the regulatory framework of the state?

- The paper must not have been previously presented or published in any research context.
- An abstract in both Arabic and English must be submitted, accompanied by keywords.
- The research paper should be written in Arabic using Simplified Arabic font, size 14 for the main text and 12 for footnotes; or in a foreign language using Times New Roman (Headings CS) font, size 12 for the main text and 10 for footnotes, with 1.0 line spacing between lines and paragraphs.
- Footnotes must be inserted automatically at the bottom of each page, and a list of references should be included at the end of the paper.
- The length of the paper should not exceed 25 pages and should not be less than 10 pages
